DESCRIPTION

The UA[™] 5 is a high quality utility amplifier ideally suited for installation applications including music-on-hold and small venue foreground music/paging systems. Features include level control and 8 ohm and 600 ohm outputs.

ARCHITECTURAL AND ENGINEERING SPECIFICATIONS

The utility amplifier shall be a single channel line level amplifier. The unit shall have one level control. Inputs to the amplifier shall be made via barrier strip connections or phono jack. Outputs shall be made by barrier strip connections. The unit shall be packaged in a rugged metal chassis 5 $\frac{5}{8}$ " wide by 2 $\frac{1}{8}$ " high by 3 $\frac{5}{8}$ " deep. One-half inch mounting flanges shall be provided on each side. The unit shall operate from standard 120 Volts AC, 60 Hz power. The amplifier shall be capable of delivering 5 watts into 8 ohms at 3% or less distortion from 50 Hz to 20 kHz with hum and noise at least 80 dB below rated power (.5%

distortion at 4 watts). The unit shall also provide a 600 ohm output. The unit shall be called the Peavey Architectural Acoustics Division model UA[™] 5.

If within one (1) year from date of purchase a properly installed product proves to be defective and Peavey is notified, Peavey will repair or replace it at no charge.
